4. Edited videos will be sent within 4-6 weeks and the first 2 re-edits are free if you request any changes.
5. In the event of an emergency if we are unable to attend the wedding a full refund will be issued.
6. The total balance must be paid in full 24 hours before the day of the wedding .
7. Hot meal and reimbursement for parking must be provided.
8. If drone cannot be flown due to weather or close proximity to an airport stock drone footage will be used.
